CHAPTER 161-4 B. OF THE LACONIA LICENSING CODE STATES:  
Notwithstanding the provisions of this section, no licensed outdoor sound equipment and/or loud speakers shall be permitted to operate past the hour of 9:00 p.m. Sunday to Thursday, and 10:00 p.m. on Friday and Saturday, with the exception of Motorcycle Week, when such equipment shall not be permitted to operate past the hour of 12:30 a.m. Sunday to Sunday. The provision shall not apply to the operation of any radio broadcasting station operating by virtue of a license from the Federal Communications Commission or loud speakers or sound equipment operated exclusively within any building or other permanent structure.
