In accordance with Chapter 195 of the City Code, this notice is to certify that on March 3, 2021, the City of Laconia's Special Event Committee voted to accept PL2021-0013MC 104 Endicott St E G-R Go-Karts Inc application and grant conditional approval for temporary parking on 104 Endicott Street East as shown on the plan received on January 25, 2021, with the following conditions:

1. Parking is for 50 + motorcycles and cars and the parking lot shall be closed by 1 AM during the event.
2. The businesses located here will not be open during Motorcycle Week.
3. There will be motorcycle parking on the Go-Cart track. The width of the track varies from 15'-18'. Applicant stated the staff is experienced in directing and controlling traffic flow for the motorcycles and pedestrians and they maintain the entry point to the Go-Cart track at 18'-19' in width.
4. Beginning on Thursday through the final weekend, at least two parking/security attendants must be on site while the lot is open. Security plan is to include prevention of loitering or tailgating along any public way on private property.
5. The applicant is responsible to have trash removed as necessary.
6. There is no vending allowed on site.
7. The site has existing fencing for safety and pedestrian circulation reasons.
8. Bathrooms in the Arcade building shall be available for public use while the parking lot is open.
9. Emergency Contact person is listed as Rusty Bertholet as 455-7010.
10. All temporary structures and all temporary signs including but not limited to banners, portable signs, and changeable copy MUST be removed by June 25, 2021.
11. All aspects of this site shall comply with Chapter 195 and Appendix A.
12. Property owner voluntarily agrees not to allow Dyno-tuners on site at any time during Motorcycle Week.
13. The applicant will be required to separate all cardboard from their solid waste stream and deposit the cardboard into containers supplied by the city which will be marked as "card-board only".

The Special Event Committee enforces the above-stated land use approval and will conduct spot inspections throughout Motorcycle Week. The SERC has authority to suspend an approval at any time and impose fines up to \$500 per violation per day if the site does not comply with the approved plan and conditions of approval under Section 195-10 of the Special Events Ordinance.
