### 5.A. **IV- Papa's Kitchen**

Discussion: Chairman Rogato stated that this location had multiple noise complaints against them last year. In early September the property owner moved the speakers facing towards the business instead of facing out towards the boardwalk and the noise complaints seemed to have stopped. Chairman Rogato has no issues if the use of the outdoor loudspeakers are being used for his patrons to enjoy and not for it to be broadcasting outside of their property and disturbing the peace. At the October 8, 2025 meeting, Mr. Parisi stated that the speakers facing the boardwalk are important to them as it attracts customers because they do not have much visibility to the public. On their application, they state the outdoor loudspeaker is for music throughout the restaurant. The board agreed that both statements are conflicting.

Chairman Rogato made a motion to rescind the approval for the outdoor loudspeaker for Off The Rails. Motion was made by Deputy Chief Loutrel and seconded by Chairman Rogato.
