## 9. CITIZEN COMMENTS FOR MATTERS NOT ON THE AGENDA

Steven Bogert- 21 Spruce Street, resident of 20 years. Came to the Council to express his deepest concerns of the events that have occurred in his neighborhood. He knows the police are doing the best they can, but there needs to be an end game. In the last 2 weeks they have had 1 death, his propane tank was taken, his neighbors propane tank was taken. He is worried that if they are coming this close to people's homes and it is not only when they are going to come into the home. There has been homeless people fighting in the street, a woman got beat up in the woods this past weekend, a man on a bicycle was doing drugs in front of someone's home who has children. They have been putting up with this for 3 years. Today they have been seen.

Christina Boisvert, 15 Spruce Street- the number of people has quadrupled over the past spring. There is a lot of theft. She has a neighbor who walks to high school who is scared to walk down the road and she has helped her give her rides, there has been a fire, stoves, propane and there is large concern for a fire in the woods.

Carl Dodge, Baldwin Street- is concerned about encampment and is in full support of the Spruce Street neighborhood, he has an enclosed porch at his house, and he has had several incidents of unwelcomed guests.

Erica Gray, 41 Spruce Street- had recently experienced a total loss house fire, there is a lot of anxiety in her household because they are the closest to the woods and she knows there is fire in the woods. She'd like to see a shelter that may not have sobriety requirements but

Shaina Hughes, 35 Spruce Street- has 3 children and likes to play outside and feels this is an issue of people who do not want to seek help, there is a long list for housing, for residential sobriety housing.

Christine Steuer, 31 Edwards Street- has lived there for 20 years, she thought it was the American dream, and now it is turning into a nightmare. She cannot sit out on her porch, people are asking for things, its only going to get worse.

Rev. Judith Wright of the Universalist Church, she is not speaking on behalf of her congregation but speaking for herself as a citizen. She sits on the mental health board and the human relations committee. She knows that this is not a simple issue, and she is saddened to hear everyone's stories tonight. She feels the main problem of homelessness is the lack of housing, not due to mental health or drug-related issues, but they are factors that are part of it. She shared a few experiences she has had with people she has helped through her congregation.

15. **MAYOR'S REPORT**

Mayor Hosmer addressed the encampment on Spruce Street, he expressed his sincerest apology to everyone who lives in that area who cannot enjoy their homes, feel safe and be able to relax in their homes. The encampment is growing, and he has been working with the City Manager, Police Chief, Community Action of Belknap and Merrimack Counties and the Director at DHHS to develop a plan to address the issues on Spruce Street. Starting on the evening of May 17<sup>th</sup> or morning of May 18<sup>th</sup> there will be a 30-yard dumpster that will be dropped off at the end of Spruce Street. They have teams of people who will be going in and cleaning out the encampment. They will make efforts and continue to make efforts to ensure that personal identification and mementos will not be thrown away. On the 21<sup>st</sup> all people will be moved out of the area. He acknowledged this was a very difficult decision and a very difficult process. He doesn't believe that all the people that are there are bad, but they are on public land and that is not allowed. We need to realize that when they move from that area they will most likely move to another part of the city. They are trying to reach out to community services to help people get help who may need help. He has visited the site several times to see who they are, how they got there and where they need to go and what obstacles they are encountering. This is a very complex situation, that demands several different solutions. The neighbors to this encampment have dealt with this long enough and they deserve to feel safe and be able to rest comfortably in their homes. Those who are using the WOW trail also have a right to use the trail and feel safe.

16. **COUNCIL COMMENTS**

Councilor Haynes pointed out that Opechee Cove has been cleaned out and all raked, 3 trees were planted on Arbor Day, and it looks absolutely Beautiful.

Councilor Felch wanted to speak about the agenda item "Paper Street" there is another he knows of, and he'd like to see the paper streets be given to the property owners and get the streets back on the tax rolls.

Councilor Cheney wants to learn the status of Leighton Ave North. There are a few catch basins and culverts that need repair and he's waiting for answers from the Public Works Director. It is his intent to offer an amendment to the short-term rental ordinance. There is a residency requirement of 150 days and he wants to see it increased to 220 days. He'd also like to suggest that the planning department application

includes the signature that they are signing is under the penalties of perjury. Councilor Lipman thinks we should look into the Court decision that just came out in Conway before we propose any changes. Councilor Cheney would also like an update on Sewer Inspection issues, and an update on the Elm Street School project.

## 20. CITY MANAGER'S REPORT

### 20.A. Financial and Operational Trends Report

Manager Beattie went over the financial and operations trends report. Highlights include new building values at 4 million for the month, welfare assistance, police activities, property taxes, motor vehicle registration, overtime, parks and rec, grievances, impact fees, no code statistics for this month, boat taxes are down a little bit but not too far off, general fund and expenditures are in a good place, EMS billing is identical to where they were last year.

Councilor Haynes asked about the Code issues on Country Club Rd. He wonders if there is someone who does a regular patrol around the city to see these items.

## 21. NEW BUSINESS

### 21.A. Discontinuance of paper street - Jefferson Street

The Town of Gilford accepted Jefferson Street (see the attached map) prior to the creation of Laconia. The section of Jefferson Street shown in the blue box, although accepted by the Town of Gilford, was never constructed.

A request has been received from Paugus Properties, LLC (please see the attached letter) that the City of Laconia discontinue this section of Jefferson Street.

If the City Council is interested in supporting Paugus Properties' request, City staff will begin the process necessary to discontinue the road under RSA 231:43. This process includes researching the form of street acceptance used by the Town of Gilford, and a public hearing with notification of the abutters a minimum of 16 days before the public hearing. All actions will be coordinated with the City Attorney to ensure proper procedures are being followed.

Councilor Cheney made a motion to table, seconded by Councilor Felch.

## 22. UNFINISHED BUSINESS

### 22.A. Resolution 2023-12 - Relative to acceptance of an award in the amount of \$82,500 from the Homeland Security Grant Program for Cybersecurity Equipment

In 2021 the City applied to the New Hampshire Department of Safety for grant funding to purchase equipment to enhance the City's cybersecurity footprint. The application was prospectively awarded in September 2022 and final approval was granted in December 2022. In early 2023 the grant award was modified to substitute additional firewall upgrades for previously requested MFA devices. This was done as the State intends to provide MFA devices to local communities under a separate grant program.

Acceptance of this award will enhance the City's cybersecurity footprint.

At the April 24, 2023 City Council meeting a motion was approved to schedule a Public Hearing on this matter; that Public Hearing was held earlier in this evening's agenda.

Councilor Cheney made a motion to waive a reading of Resolution 2023-12 in its entirety and to read by title only. Seconded by Councilor Haynes. **Discussion: None**

The ***Motion passed with all in favor.*** 5-0

Councilor Felch made a motion to move a second reading of Resolution 2023-12 relative to acceptance of an award in the amount of \$82,500 from the Homeland Security Grant Program for Cybersecurity Equipment. Seconded by Councilor Cheney. **Discussion: None**

Councilor Cheney made a motion to approve Resolution 2023-12 relative to acceptance of an award in the amount of \$82,500 from the Homeland Security Grant Program for Cybersecurity Equipment as presented, and to authorize the City Manager to sign all documents related to this grant. Seconded by Councilor Haynes. **Discussion: None**

22.B. **Lease Agreement between the City of Laconia/Laconia Airport Authority and Poppy's Choice, LLC, having a principal place of business at 15 Airport Road, Gilford, NH 03249**

Item

This is a new Lease. POPPY'S CHOICE, LLC is purchasing the building located at 15 Airport Road, Gilford, NH, on Laconia Municipal Airport property.

- The Lease Agreement duration is 40 years in length, to be reviewed in 20 years to negotiate a new rate. Note: This is a standard – “boiler plate” lease agreement. Unless requested by a tenant, the typical lease agreement is 40 years. Precisely at the midpoint, the agreement provides for a reassessment of the lease rate in the event that the amount has escalated unreasonably or is not in line with the market rate.

- The agreed rate is \$0.1499 per square foot per usable acre for the 2023-2024 FY with adjustments according to the December CPI-U each successive year.

This request was initially included in the Council's April 24, 2023 agenda packet. At that meeting members of the Council had questions regarding the duration of the lease and the time frame for negotiating a new rate of the lease. This revised Staff Report is being provided to address those concerns, and Airport Manager Marv Everson will be present at the meeting to answer any additional questions the Council may have. A motion was made at the April 24th meeting and approved to table this request to this evening's meeting.

At a meeting on Thursday, April 20, 2023, the Laconia Airport Authority authorized Andrew J. Hosmer to sign the agreement as its Chairman.

- The Laconia Airport Authority is seeking approval from the City Council for Andrew J. Hosmer as Mayor, or Kirk Beattie as City Manager to sign the agreement on behalf of the City of Laconia.

Councilor Felch made a motion to take this item off the table. Seconded by Councilor Haynes. **Discussion: None.**

The ***Motion passed with all in favor.*** 5-0

Councilor Felch made a motion to approve the authorization for Andrew J. Hosmer as Mayor, or Kirk Beattie as City Manager, to sign the Lease Agreement for Poppy's Choice, LLC, for the building

located at 15 Airport Road, Gilford, NH on Laconia Municipal Airport property, as presented. Seconded by Councilor Haynes. **Discussion: Councilor Lipman thinks the term of the lease is too long but will vote in support since this is the same model that has been done in the past.**

## 22.C. **Ordinance 2023-205-2, Naming Rights and Procedures for City-Owned Property**

Councilor Felch requested that the Governmental Operations & Ordinances Committee discuss naming privileges for public areas.

Pursuant to Councilor Felch's request, City Manager Beattie researched several New Hampshire cities to determine how they handle the naming of city buildings, fields and places (other than streets), and presented that information to the Government Operations & Ordinances Subcommittee at their March 27 and April 24, 2023 meetings. At the April 24 meeting the Subcommittee approved a motion to bring the proposed language to the full City Council for review and to schedule a Public Hearing.

Councilor Haynes made a motion to waive a reading of Ordinance 2023-205-2 relative to naming rights and procedures for City-owned property and to read by title only. Seconded by Councilor Cheney. **Discussion: None.**

The **Motion passed with all in favor.** 5-0

Councilor Felch made a motion a first reading of Ordinance 2023-205-2 relative to naming rights and procedures for City-owned property. Seconded by Councilor Cheney. **Discussion: None.**

The **Motion passed with all in favor.** 5-0

Councilor Felch made a motion to schedule a Public Hearing on May 22, 2023 during the regular City Council meeting to gather public input prior to any action being taken. Seconded by Councilor Soucy. **Discussion: None.**

## 22.D. **Elm Street School walking path**

The Laconia School District and the City of Laconia are working in conjunction with each other to construct a walking path, from Elm Street School through the woods and connect with Washington Street. The path is planned to be built to road standards, to allow for future conversion from walking path to driving lane. The reason for the proposed project is to alleviate the traffic congestion on Elm Street during after-school child pickup, and to provide a safe way for students to walk from the school to Washington Street without being on Elm Street. The City Council is asked to schedule a Public Hearing to gather public input on this matter. The public hearing will describe the construction plan, as well as advising residents around Elm Street School of any proposed or potential impacts.

Manager Beattie began the discussion, Councilor Felch would like to see a plan that details what it looks like, Council Cheney agreed.

Councilor Cheney made a motion to schedule a Public Hearing on May 22, 2023 during the regular City Council meeting to gather public input on the Elm Street School walking path prior to any action being taken. Seconded by Councilor Felch. **Discussion: None.**
