5.I. Acceptance of minutes from September 22

Whether the district should be expanded and where to expand. After some discussion Chair T. Shore suggested the Commission come up with buildings they think is significant throughout the City.

Planning Director D. Trefethen brought up Mae Williams' project with the Heritage Commission and that will be a start as well. He reminded that any changes will need to go before Council and explained the process. M. Haynes gave a brief background on how this all came about. He also noted that as of Monday, the City owns the Rectory Building of former St. Joseph's church.

Chair T. Shore suggested the Commission look through all the materials over the next few months and start creating a list for expansion. She would like to see M. Williams' report prior to actually moving forward.

The Commission brainstormed ideas on how to publicize what the Commission does. One idea was to partner with the Historical Museum another was to have programs at the Belknap Mill.
