PUBLIC INFORMATION MEETING NOTICE



PUBLIC INFORMATION MEETING US ROUTE 3/WEIRS BOULEVARD BRIDGE OVER LANGLEY BROOK, LACONIA, NH

The City of Laconia is announcing that a public informational meeting will be held to discuss the proposed Rehabilitation or Replacement of US Route 3/Weirs Boulevard Bridge over Langley Brook, NHDOT Bridge No. 135/128.

The meeting will be held at the City Hall - Conference Room 200A, 45 Beacon Street E, Laconia, NH 03246 on Wednesday, February 15th, 2024 at 6:00 pm.

The City's Engineer (Hoyle, Tanner & Associates, Inc.) is developing an engineering study for the rehabilitation or replacement of the existing bridge and reconstruction of roadway approaches within the vicinity of the bridge.

US Route 3/Weirs Boulevard over Langley Brook is a municipally owned redlisted bridge due to its poor structurally deficient condition. A partial closure or reduced load carrying capacity is imminent in the near future if the bridge is left as is.

The public is encouraged to attend the meeting, to hear the general overview of the program funding requirements, rehabilitation and replacement alternatives, find out the proposed project schedule, provide input and ask questions concerning this project.

THE WORLD CHAMPIONSHIP SLED DOG DERBY



Prevention Better Than Reaction

As the Water Department is nearing its completion of our annual winter preparation/prevention program, this is a reminder for our customers to keep in mind the potential of water pipes freezing.

If the temperature inside a house gets below 32 degrees Fahrenheit (0 degree Celsius) it's likely that the water supply pipes and the drain traps will freeze. When water freezes it expands 9 percent, and if there is no room for expansion, it's possible that the pipe will develop a crack and eventually leak once the ice thaws out. Fixing a ruptured pipe can be expensive, but the damage from uncontrolled water leakage can easily reach into the thousands of dollars.

The majority of the calls received for frozen water pipes and water meters are a result of inadequate heating and cold air drafts where piping is located in the home. It is recommended that property owners check their property for these conditions and identify the location of their water meter and shutoff valve before an emergency.

The property owner is ultimately responsible for repairs to the piping within the home or building. The Water Department will replace frozen or damaged meters. Customers will be charged for the cost of the replacement of the meter and service calls, as applicable.

If for any reason you cannot stop the flow of water from a broken pipe, call the Water Department's 24-hour emergency number at 603-524-0907.



LACONIA WATER DEPARTMENT METER MAINTENANCE PROGRAM



Meters are changed periodically to comply with the Public Utilities Commission's Rules and Regulations, the American Water Works Association and in accordance with the Laconia Water Works' Tariff.

The Water Department has an annual program that replaces meters and **there is no cost to the property owner**. Our goal is to change out these meters over the winter months.

The Water Department will contact those property owners whose water meters are due to be changed.

We are in the process of sending letters and making phone calls to schedule appointments. This process takes approximately 20-30 minutes.



Ending Care Appeals

If you are receiving care in a hospital or non-hospital setting and are told that your Medicare will no longer pay for your care, you have the right to a fast appeal if you feel that continued care is medically necessary. There are separate processes for hospital and non-hospital appeals. Non-hospital care includes care from a skilled nursing facility (SNF), Comprehensive Outpatient Rehabilitation Facility (CORF), hospice, or home health agency. You can appeal by following the instructions on the notices you receive.

Hospital Discharge Appeal

Important Message from Medicare: Your provider should give you this notice within two days of entering the hospital as an inpatient. This notice includes instructions for how to appeal.



Beneficiary and Family Centered Care- Quality Improvement Organization (BFCC-QIO): To file an expedited appeal, call the BFCC-QIO by midnight of the day of your discharge.



Detailed Notice of Discharge: Once you contact the BFCC-QIO, the hospital must send you this notice. It explains in writing why your hospital care is ending.



The BFCC-QIO should call you with its decision within 24 hours of receiving all the information it needs.



Non-Hospital Discharge

Notice of Medicare Non-Coverage: You should receive this no later than two days before your care is set to end. If you receive home health care, you should receive this notice on your second-to-last care visit. This notice tells you when your care is ending and explains how to appeal.



BFCC-QIO: File an expedited appeal by noon of the day before your care is set to end.



Detailed Explanation of Non-Coverage: Once you contact the BFCC-QIO, your provider should give you this notice. It explains in writing why your care is ending.



If you have Original Medicare, the BFCC-QIO should make a decision no later than two days after your care is set to end. **If you have a Medicare Advantage Plan,** the BFCC-QIO should make a decision no later than the day your care is to end.
