CODE ENFORCEMENT DEPT. **Decks, Sheds and Pools**

The Code Department is getting ready for Permit Applications for spring construction of Decks, Sheds and Pools! This is considered a Minor Building Permit and the [Application Form](#) is available online. Following are some helpful hints as you plan to submit your application for a shed:



SHEDS:

- Exempt from a Building Permit if they are under 150 sq ft
- Note setbacks to property lines. (Sheds are allowed to be located within 10 ft of a rear property line if they are under 12 ft tall.)
- If you live in an association, please submit a letter of approval from your homeowners'/ condominium association.
- Green space calculations shall be provided if your property is nearing the maximum lot coverage.

SPEEDING

Speeding in residential areas causes harm to others.


- It makes citizens fear for children's safety.
- It makes pedestrians and bicyclists fear for their safety.
- It increases the risk of vehicle crashes.
- It increases the seriousness of injuries to a speeder's own passenger(s) and to other drivers and passenger(s), pedestrians and bicyclists a vehicle strikes.

Speeding increases the risks of crashes and injuries.

- The driver is more likely to lose control of the vehicle.
- The vehicle safety equipment is less effective at higher speeds.
- The distance it takes to stop the vehicle is greater.
- The vehicle travels farther during the time it takes the driver to react to a hazard.
- Crashes are more severe at higher speeds.

Many drivers admit to speeding in residential areas. Their reasons for speeding include running late and wanting to make up for lost time, being unaware of the speed limit and trying to keep up with other traffic.

The Laconia Police Department makes a concerted effort to address the speeding motorist problem that comprises the quality of life in our neighborhoods. The Police Department conducts dedicated patrols throughout all hours of the day and night to help in our fight with speeding motorists.



The Laconia Police Department utilizes a radar board which shows the speed of passing vehicles and a Stat Pack which records the speed of all vehicles traveling in both directions in our effort to reduce speeding.

The Laconia Police Department asks for the assistance of everyone by reducing their speed and not hesitating in contacting us if needed.

Update: Lilies For The Lakes Region



"Lilies for the Lakes Region", sponsored by the Laconia Rotary Club, is an effort to plant 10,000 daylilies in the next 3 years, all over the Lakes Region. A "Call for Volunteers" for this local landscape enhancement effort turned out beautifully, as did the plantings. The first volunteer planting day was Saturday May 5th, where over 30 people gathered at Laconia's Rotary Park bandstand. Volunteers were asked to bring a smile and a shovel and were provided planting instructions, a bag of day lilies and a nearby planting location. The Opechee Garden Club, the Laconia 4-H Club, the Lakes Region Boys & Girls Club and a number of individual volunteers lent a hand.

Local Business owners like John Moriarity, Laconia Rotarian and owner of Eight Gables Mall on Union Avenue (Domino's & Subway restaurants), bought some of the daylilies to enhance the publically viewed parts of their properties, funding the next batch of plant purchases. Moriarity was assisted by a busload of Boys & Girls Club kids and members of the Gilford Rotary. The 1st batch of about 1,000 lilies, previously dug, split & packaged by volunteers, are now in the ground. More are on the way, the next volunteer planting date will be announced. Updates from the Planning Office...



So what is a Brownfield? The Laconia Planning Department has used this term quite a bit over the last few years, in grant applications and in relation to the former Lakes Region facility property. According to the EPA the term "brownfield site" means real property, the expansion, redevelopment, or reuse of which may be complicated by the presence or potential presence of a hazardous substance, pollutant, or contaminant."

In 2011 the Planning Department completed several assessments under an EPA Assessment grant that the Lakes Region Planning Commission received. In April of 2012 the Planning Department received an EPA Targeted Brownfields Grant for further assessment of the structures on the former Lakes Region Facility property. This \$40,000 grant, fairly small in size, will be used to assess environmental hazards such as lead paint, asbestos and PCBs. As part of the grant, the consultant will put together a plan for cleanup, including a cost estimate. This will be valuable information for potential developers of the site or to be used to apply for cleanup funds.

By participating in the EPA program for assessment, properties have a high likelihood of qualifying for a cleanup grant from the EPA. If you are interested in participating in a City-wide Brownfields Committee to help identify future sites for funding, please contact the Planning Director, Shanna B. Assessing

Important DATE!

Now is the time to file for NH State Low and Moderate Income Homeowners Property Tax Relief! Form DP-8 must be filed no later than June 30, 2012. The State no longer mails the forms to property taxpayers who have filed in prior years.

You are eligible to file for this tax relief if:


- You own a homestead subject to the state education property tax;
- You have resided in such homestead on April 1 of the year for which the claim for relief is made;
- You have a total adjusted gross household income of \$20,000 or less if a single person, or \$40,000 or less if married or head of a NH household.

Be sure to attach a copy of your final 2011 property tax bill and your 2011 federal tax return for each claimant and all adult members of the claimant's household for the corresponding period.
