Attention tenants of large multifamily complexes:

Rental properties with over 4 apartments or condominiums are only authorized four sets of solid waste containers. These containers have the City of Laconia stamped into the barrel. Some landlords have arranged for private service to supplement the disposal of solid waste from their complexes. If the private service is provided by Waste Management the containers will have "WM" stamped into the barrel. If the private

service is provided by Casella the containers will have "Casella" stamped into the barrel. Other firms may or may not provide barrels with their logo.

The company providing the private service may empty these containers the same day as the City's service or on a different day.

If the private containers are not emptied, please call your landlord or the company that is providing the service. Do not call Public Works as the City's contractor does not empty these private containers. Thank you for your help!



City Curbside Solid Waste Collection during the winter for residents and businesses with curbside collection

Where and how to place your solid waste containers during the winter to ensure the containers can be emptied

Treat your solid waste containers as a mailbox! What happens if you do not dig out your mailbox after a snowstorm? The Post Office does not deliver mail!

For solid waste collection if you put your solid waste containers behind snowbanks, they cannot be emptied.

For rural area residences and businesses without sidewalks -

Place your containers in your driveway near the edge of the road, or dig out an area in the snowbank to create an opening in which to place your containers. Make sure the opening is 2 feet wider on each side than the containers. The depth of the opening only has to be deep enough to provide 1 foot of clearance from the back of the container.

For residents and businesses in areas of the City with sidewalks -

Place your containers in your driveway near the edge of the road.

If you do not have a driveway or the driveway is too small and:

Where the sidewalk is against the curb at the edge of the road, dig an opening through the snow bank out to the street in which to place your containers.

Make sure the opening is 2 feet wider on each side than the containers.

If there is a grass or gravel area between the sidewalk and the edge of the road:

Place the containers in your driveway near the edge of the road, or dig out an area in the snowbank to place your containers.

Make sure the opening is 2 feet wider on each side than the containers. The depth of the opening only has to be deep enough to provide 1 foot of clearance from the back of the container.

Please do not place your containers out for collection before 7 pm the night before your scheduled collection day, and bring them back to the residence or business at the end of the collection day. Do not leave your containers on the sidewalk so that pedestrians can use the sidewalk. If collection is canceled due to a major snowstorm, please bring the containers back onto your property so that the City's plow crews can keep the streets and sidewalks open for your use.

Will the contractor collect containers during a snowstorm? The contractor will provide curbside solid waste collection service during a minor to moderate snowstorm.

The contractor and Public Works consider canceling collection services when forecasters are predicting blizzard or near blizzard conditions. If the contractor decides to cancel collection due to the forecast, the City will post the cancellation notice on the City's [website](#) in the banner section on the top of the City's home page. For those residents who have signed up to receive City alerts, you will receive an e-mail informing you that solid waste will not be collected and the collection schedule for the remainder of the week. If you are not yet signed up to receive alerts and wish to do so, please sign up [here](#).

Solid waste collection and snow plowing -

Public Works leaders and crews will adjust their plowing procedures during minor to moderate storms to minimize the impact of plowing on scheduled curbside collection. Laconia Residents....It's time to register your dog!

Per RSA 466:1 all dogs residing in the City of Laconia must be registered with the license number issued imprinted, as well as a paper license. The tag issued must be worn on the dog's collar at all times. Please remember that a valid rabies certificate and proof of inoculation (if applicable) are required to register.

All dogs need to be registered by April 30th of each year.



We are happy to help register your dog in person here in City Hall or you can use our on-line registration. Just click the image (left). When processing your registration online, please be sure to add the two or three digit prefix (22- or VET-.)

For the comfort and safety of all, we ask that you leave your dog at home when you come into City Hall to conduct business. Although we love seeing your four-legged family members, we would like to encourage you to be conscious of others. As always, certified service animals are welcome.

This was 'Black Brook Hill' looking south in 1961, with the Arthur and Rose Davis house at 1197 Union Ave., at near left, the Roland 'Bud' Bolduc house, next to it, and the Acme Oil Co. (later Labbe) oil tanks at the crest of the hill on the left, with the Edward and Myra Paige house beyond them; and the Tekwood office building at near right. 
... AND NOW

Much industrial, retail and service development has occurred in this section over the past 60-plus years. HK Power Sports has replaced the Davis House, at left, with Sparkle Clean Car Wash, Five Star Golf Carts & Utility Vehicles and Mike's Quality Car Care further up the hill. The Black Brook Bridge railing is glimpsed at lower right, with T-Bones and Cactus Jack's just up the hill beyond. Tekwood, a manufacturer of pressed veneer board, closed in April 1962. Our yesterdays

THEN ...

Fire, Dec. 1, 1928, gutted this New Salem Street building, across the railroad tracks from the Laconia Passenger Station. 'Several lines of hose were laid and after battling with the flames for more than an hour the firemen got the fire under control. A large wooden building, owned by the company and used by them for a storehouse adjoining [to the left] was saved in the nick of time just as flames were discovered under the eaves and roof,' according to The Citizen's account. The building had been built in 1896 by the O'Shea Brothers, who established a hosiery factory there. From around 1905 to 1908, Albert E. Sanborn manufactured 'children's fine cashmere hosiery' there and around 1912 the Belknap Stocking Co. occupied the premises. George W. Mayo began the needle company in 1920. ... AND NOW

The building — which would have been located in the parking lot, just beyond the cannon at left — was repaired and the Granite State Needle Co. continued for awhile after the fire, in competition with the Laconia Needle Co. on Union Avenue. Much later, the C.A. Lund Co. rented the building for storage of skis. The Laconia Clinic acquired the building in 1957 and had it torn down in early April 1958 to increase its parking lot. Public Works Department Property Owner's Winter Survival Tips!

The best place to deposit snow when clearing your driveway is to put the snow downstream of your driveway. (Downstream is the direction the plow truck travels.) When Public Works plows the street the snow will be pushed away from the driveway instead of towards it.

Be nice to your neighbor and take them into consideration when you are clearing your driveway!

Also, you can minimize the amount of snow plowed into your driveway by creating a pocket in the snow just upstream of your driveway. This pocket will allow some of the snow on the plow to fall off into the pocket, resulting in less in your driveway!

City plow trucks have wing plows on them and, like delivery companies, we always want to turn right. This causes properties on an inside corner to have areas of deep snow. Corner lot owners should take this into consideration when developing methods to minimize the impact of snow coming off from a plow blade.

Carbon Monoxide Safety



Often called the invisible killer, carbon monoxide is an invisible, odorless, colorless gas created when fuels (such as gasoline, wood, coal, natural gas, propane, oil, and methane) burn incompletely. In the home, heating and cooking equipment that burn fuel can be sources of carbon monoxide.

- CO alarms should be installed in a central location outside each sleeping area and on every level of the home and in other locations where required by applicable laws, codes or standards. For the best protection, interconnect all CO alarms throughout the home. When one sounds, they all sound.
- Follow the manufacturer's instructions for placement and mounting height.
- Choose a CO alarm that is listed by a qualified testing laboratory.
- Call your local fire department's non-emergency number to find out what number to call if the CO alarm sounds.
- Test CO alarms at least once a month; replace them according to the manufacturer's instructions.
- If the audible trouble signal sounds, check for low batteries. If the battery is low, replace it. If it still sounds, call the fire department.
- If the CO alarm sounds, immediately move to a fresh air location outdoors or by an open window or door. Make sure everyone inside the home is accounted for. Call for help from a fresh air location and stay there until emergency personnel declare that it is safe to re-enter the home.
- If you need to warm a vehicle, remove it from the garage immediately after starting it. Do not run a vehicle or other fueled engine or motor indoors, even if garage doors are open. Make sure the exhaust pipe of a running vehicle is not covered with snow.
- During and after a snowstorm, make sure vents for the dryer, furnace, stove, and fireplace are clear of snow build-up.
- A generator should be used in a well-ventilated location outdoors away from windows, doors and vent openings.
- Gas or charcoal grills can produce CO — only use outside.

HOME HEATING EQUIPMENT



Have fuel-burning heating equipment and chimneys inspected by a professional every year before cold weather sets in. When using a fireplace, open the flue for adequate ventilation. Never use your oven to heat your home.

FACTS

- ! A person can be poisoned by a small amount of CO over a longer period of time or by a large amount of CO over a shorter amount of time.
- ! In 2010, U.S. fire departments responded to an estimated 80,100 non-fire CO incidents in which carbon monoxide was found, or an average of nine calls per hour.

ATTENTION SNOWMOBILERS!

Snowmobiles in the Boardwalk area of Weirs Beach must be on the State Snowmobile trail. Please do not ride on the sidewalks on Lakeside Avenue!

The City used to move the State snowmobile trail onto Lakeside Avenue to protect the Boardwalk. Since completion of the project to improve Lakeside Avenue, the snowmobile trail is back on the tracks. The City wants all snowmobilers to remain on the State trail through the Boardwalk area to protect the improvements that we have made to the area. The City of Laconia has not authorized snowmobiles to operate on any of its sidewalks or roads.

Please do not use the sidewalk to travel to Cumberland Farms from the trail. The City is clearing the sidewalks of snow so that the residents in the area have place to walk in the winter.

Under State law it is unlawful to:

- Operate on any road or within the right-of-way except where authorized and posted.
- Operate on town roads or sidewalks unless posted for OHVs or snowmobiles.
- Operate on or across any highway bridge unless posted as open for OHVs or snowmobiles.

On behalf of the Laconia School District, happy 2024! If you can believe it, we are almost halfway through the 2023-24 school year. We have some amazing students in our schools, some of whom I would like to highlight for you in this newsletter:

New Hampshire Civics and Civility Event (January 11)

LHS Principal Lisa Hinds and I were on a team with educators from the Manchester School District, former NH State Board of Education Chairperson Fred Bramante, and the NH Department of Education to organize a National Presidential

Youth Convention with the theme of Civics and Civility. This event took place on Thursday, January 11 before the New Hampshire Presidential Primary at the City Auditorium (The Audi) in Concord. The event was purposefully non-partisan and was endorsed by Governor Chris Sununu, Senator Jeanne Shaheen, and Congressman Chris Pappas. It brought together students from across the state for a half-day civics lesson aimed at building our students' knowledge and skills around civics and civility. A group of students from Laconia High School attended the event and were given the opportunity to sign a Declaration of Civility associated with the event.



City of Laconia MLK Event (January 14)

There was a Laconia Celebration of Reverend Dr. Martin Luther King, Jr. at the Colonial Theatre that our students presented and performed at on Sunday, January 14th. This event was organized by the Laconia Human Relations Committee and its Chairperson Patrick Wood. Mr. Wood, Mayor Andrew Hosmer, Senator Jeanne Shaheen, County Attorney Andrew Livernois, and Ward 4 Laconia School Board member LaToya Beck were among the featured speakers. There were several displays of student work at the event. Pleasant Street School students led by Art Teacher Jeanne Blair, created models of quilts with patterns that were made by enslaved African Americans before the Civil War, some of which were used as codes to help slaves on a path to freedom on the Underground Railroad.



LHS Art Teacher Alison Witham's students' displayed an "Illuminated Letter" project based on the decorations of medieval manuscripts. Students learned about the history of medieval manuscripts and various watercolor techniques. Students also learned about the life and legacy of Dr. King and chose a quote that was meaningful to them that they copied. They "illuminated" the first letter by adding various designs around it. Students then provided a brief statement about why they chose the quote they selected.


